The undersigned does not assume the risks of injuries caused by the gross negligence, or willful or wanton misconduct of any officials, officers, employees, or agents of Hardcore Elite Baseball and Any and/or All Head Coaches, Assistant Coaches or Trainers for All Represented Hardcore Teams Age Groups.
- 2. Release.
